(Effective Upon Digital Acceptance)

1. Spiritual Intent & Mutual Understanding

This agreement is not intended to limit spiritual expression, personal modalities, or the free sharing of universal wisdom, which belongs to no single individual.

This agreement exists to protect:

- non-public operational and business information
- the energetic and professional integrity of the collective

It does not claim ownership over spiritual wisdom, healing modalities, personal teachings, or a practitioner's independent work.

By entering this agreement, all parties affirm their commitment to transparency, accountability, and collaboration; allowing the mission to remain heart-centered, sustainable, and in service to humanity.

2. Parties

This Confidentiality and Non-Disclosure Agreement ("Agreement") is entered into by and between:

Jaded I'lluzions

("Disclosing Party" / "Company")



&

Any individual or entity creating an account, accessing services, or engaging in business interactions on the Jaded I'lluzions platform ("Receiving Party" or "User").
(Collectively, "the Parties")

By accessing or using the platform, the Receiving Party acknowledges and agrees to be bound by the terms of this Agreement.

3. Purpose of the Agreement

The Parties may, during the course of service use, onboarding, or platform interaction, exchange information relating to business operations, systems, intellectual property, healing methodologies, digital content, or strategic initiatives ("Business Relationship").

This Agreement governs the confidentiality of information exchanged during such Business Relationship.

4. Definition of Confidential Information

"Confidential Information" includes all non-public information disclosed by the Company, whether communicated verbally, visually, electronically, or in writing. Such information includes but is not limited to:

» 4.1 Business & Operational Information

- Platform structure, system logic, architecture, algorithms, reward systems, Light Wallet data
- Marketing plans, strategy documents, brand frameworks, user experience flows
- Internal research, financial projections, performance metrics

» 4.2 User & Healer Information

- Personal details, healing session notes, preferences, communications
- Marketplace activity, booking data, product purchase information

» 4.3 Digital & Creative Content

- Audio, video, written materials, eBooks, session content
- Platform branding, visual assets, proprietary methodologies

4.4 Any information reasonably expected to be understood as confidential.

5. Exclusions From Confidential Information

Confidential Information does not include information that:

1. Becomes public without breach by the Receiving Party;
2. Is lawfully obtained from a third party without confidentiality obligations;
3. Is independently developed without reference to Company data;
4. Is required by law to be disclosed (with prompt notice to the Company where permitted).

6. Ownership of Information

The Receiving Party agrees to:

» 6.1 Protection

Use all reasonable measures, no less than those used to protect its own confidential data, to maintain confidentiality.

» 6.2 Restrictions on Use

- Not use Confidential Information for personal gain, competition, or external disclosure
- Not copy, distribute, or reproduce materials without written consent
- Not exploit user data, healer data, financial information, or platform logic

» 6.3 Return or Destruction

Upon request, or upon closure of an account, the Receiving Party must immediately delete, destroy, or return all Confidential Information in its possession.

» 6.4 Third-Party Access

Disclosures are permitted only to individuals who require the information for legitimate participation, and only if bound by comparable confidentiality obligations.

7. Ownership of Information

All Confidential Information remains the exclusive property of **Jaded Illuzions**. No license or intellectual property rights are granted under this Agreement.

8. Term & Survival

Confidentiality obligations:

- Begin immediately upon accessing the platform
- Continue during the Business Relationship
- **Survive for five (5) years** following account termination or the end of involvement

9. Remedies for Breach

The Parties acknowledge that:

- A breach may cause irreparable harm
- Monetary damages may be insufficient

Therefore, Jaded I'lluzions is entitled to seek **injunctive relief**, damages, account suspension, or any remedy available under law.



10. Notices

Notices or legal communications may be delivered via:

- Email
- Registered mail
- Platform-based messaging

Notices to Users shall be sent to the email used for registration.

11. Governing Law

This Agreement is governed by:

- United States law (State of Virginia) for global users
- Australian Consumer Law (ACL) where applicable to Australian interactions
- Users agree to submit to the non-exclusive jurisdiction of courts in both regions
